Prospective Offerors interested in attending the PAS Existing Conditions Exploration must confirm attendance by emailing the Procurement Officer no later than seven (7) calendar days prior to the commencement of the PAS Existing Conditions Exploration and include the number of personnel attending. Prospective Offerors are allowed a maximum of two (2) personnel in attendance, but it is strongly encouraged to limit attendance to one (1) personnel. Attendees must meet outside the front entrance of the Aviation Headquarters building located at 2485 E Buckeye Rd Phoenix, AZ 85034. The two-night PAS Existing Conditions Exploration will include the viewing and inspection of areas above the ceiling throughout the Airport, and any other

pertinent areas, as determined solely by Aviation. Aviation will provide access (i.e. ladders) to view the ceiling areas, but no protective or safety equipment will be provided. Please plan accordingly and remember all items are subject to Transportation Security Administration (TSA) screening.

Attendees may be subject to TSA screening. Please bring a TSA-approved form of identification (e.g. state-issued driver's license or U.S. passport).

Offerors are strongly encouraged to attend the in-person PAS Existing Conditions Exploration. However, attendance is optional and not mandatory. The City reserves the right to change dates, times, and locations as necessary of the PAS Existing Conditions Exploration.
