REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified consultant to provide Engineering Services for Phase 2 of the 16-Inch Paradise Valley Zone 3C Improvements. Services will include construction administration and inspection and potential design services if necessary due to field conditions or major construction changes. The project includes a new Pressure Reducing Valve Station located on Shea Boulevard approximately 600 feet west of Tatum Boulevard, then along Tatum Boulevard to Mountain View Road, then along Mountain View Road to 52nd Street. The estimated construction cost is \$5.5 million.

SECTION I – PROJECT DESCRIPTION

The Pressure Reducing Valve Station (PRV) will be located on the southwest corner of Shea Boulevard and 45th Place. The PRV Station will be built in a new vault in an existing utility easement near the northwest corner of the property. New piping connections will also be needed in Shea Boulevard connecting to the PRV Station.

The project also includes a new 16-inch water transmission main from the PRV site east along Shea Boulevard to Tatum Boulevard, then south along Tatum Boulevard to Mountain View Road, then east along Mountain View Road to 52nd Street. The 16-inch waterline alignment is approximately 6,000 linear feet.

SECTION II – SCOPE OF WORK

The selected firm will provide construction administration and inspection services (CA&I) and possible design for this project. The selected firm will provide an individual to manage, lead their team and commit this individual to the project for its duration. The firm's individual will serve as the City's representative during construction and will work with and under the direction of the Water Services project manager. Services provided will include, but are not limited to:

- Participation in final design meetings and review of construction plans and specifications.
- Review of and recommendations regarding cost models/Guaranteed Maximum Price provided by the Construction Manager at Risk contractor.
- General project administration, construction inspections, and special pipeline inspections.
- Provide resident engineering services during construction and act as the City's representative.
- Develop project schedule with the Contractor.
- Provide daily interaction with contractors to clarify job requirements.
- Conduct pre-construction conference and hold on-site and off-site meetings as appropriate with Contractor, City staff, impacted third parties, utilities, and regulatory agencies as required.
- Represent City and coordinate with regulatory agencies, utilities, and impacted third parties as required.
- Monitoring of job progress and keep City informed of project status and issues. Provide weekly status updates.
- Authorize changes as necessary due to construction or other issues arising from the work.
- Issue interpretations and clarifications of the construction documents.
- Review shop drawings and test results.
- Perform record keeping and maintain project documents including correspondence, schedules, submittals, test data, payments, meeting minutes, specifications, drawings, photographs, shop drawing, as-builts, etc.
- Review and certification of progress payments and change orders.
- Review of contractor red-lines and preparation or coordination of the development of record drawings in accordance with City standards and Water Asset Management mapping requirements.
- Public Information and Outreach services.
- Coordination among City departments, governmental agencies, and operations staff.
- Review of pipeline shutdown and startup plans.
- Other services as required to support successful completion of the work and the City's interests.

In addition to the CA&I services, the contracted firm may provide design services for this project if field condition or construction changes necessitate this. If design services are needed, then the scope of work will include, but not be limited to:

- Design adjustments to the 16-inch transmission main alignment and connections points to the distribution/transmission system and connections to the PRV Station.
- Design adjustments to the new PRV Station.
- Provide construction documents and specifications for any design changes to the 16-inch transmission main and new PRV Station as described above.
- Develop preliminary Maintenance of Plant Operations plans for pipeline shutdown and recharge.
- Coordinate with the Street Transportation and other City Departments as required on right-of-way and/or City owned property.
- Coordinate with the Town of Paradise Valley and other stakeholders as needed.
- Identify all utility locations both vertically and horizontally along the pipeline route. Coordinate with the City's potholing contractor as necessary to establish utility locations.
- Coordinate with other design consultants on adjacent projects, as needed.
- Conduct geotechnical evaluations to develop construction requirements.
- Investigate and identify traffic control impacts and costs using the City's Right-of-Way Management Program.
- Obtain all applicable permits.
- All City standards shall be used to develop construction documents including but not limited to drafting standards and MAG standard specifications.

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

SECTION III - PRE-SUBMITTAL MEETING

A pre-submittal meeting will be held at 1:00 a.m. on January 17, 2024, at 200 W. Washington Street, City Hall Conference Room 8 East **AND** via Teams. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested consultants attend the pre-submittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

SECTION IV - STATEMENT OF QUALIFICATIONS EVALUATION CRITERIA

A Firm will be selected through a qualifications-based selection process based on the criteria below. Sub-criteria are listed in order of importance in relation to project services. City of Phoenix project experience is not required.

4. Identify the location of the lead firm's principal office and the home office location of key staff on this project

G. Reference Check (maximum 21 points*)

Use the form provided (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

SECTION V - SUBMITTAL REQUIREMENTS

New Electronic Submittal Process: Firms interested in this project must submit a Statement of Qualifications (SOQ) electronically through the ProcurePHX online portal.

Submittal requirements are as follows:

- Vendor Information: All firms must be registered in the City's Vendor Management System prior to submitting a proposal. For new firms, the City will send an email to your firm with a vendor number within two business days of submitting the request. The vendor number should be included on the cover of the SOQ. Submittals:

- Submittals must be uploaded to the ProcurePHX website by the submittal due date and time.
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name, vendor number, project title, and project number on the cover of the SOQ.
- A maximum of **12 pages** is permitted to address all content in the SOQ submittal. **(Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)**

- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11".
- Font size must not be less than 10 point.
- Content count:
 - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
 - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
 - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages **will NOT** be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.

- ☑ **Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, **legal firm name (not a trade name)**, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. Do not include any additional information.

Note: All pages exceeding the specified maximum page limit will be removed from the submittal and not considered in evaluating a submitted SOQ.

SECTION VI – GROUNDS FOR DISQUALIFICATION

The following **will be grounds for disqualification**, and will be strictly enforced:

- Uploading of submittal to the wrong project.
- Violating the “Contact with City Employees” policy contained in this RFQ.

SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least three, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

All submitting firms will be notified of selection outcome for this project. The status of a selection on this project will be posted on the City of Phoenix’s “Tabulations, Awards, and Recommendations” website:

The selected Consultant should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement’s contract provisions.

SECTION VIII – GENERAL INFORMATION

Citywide Capital Improvement Projects. Consulting and contractor services supporting the City’s Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. *Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification.* The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

Alternate Format. For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

Release of Project Information/Public Records Request. The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City. To submit a Public Records Request, visit phoenix.gov/prr.

City Rights. The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

Contact with City Employees. This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.**

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

Conflict of Interest. The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

Protest Procedures. Firms responding to disqualification, or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
