Additionally, each domain should include an analysis of the causes and conditions of poverty, and any prevailing strategies found to address the barriers identified.	
10: What is the budget for this project?	10: The offerer should simply be encouraged to identify a reasonable budget that covers all aspects of the Scope of Work	
11: Are you looking for 1 large community needs assessment and then a review and update yearly, which will be a community needs assessment yearly?	11: The Scope of Work Consultant Deliverable Requirements on Page 23 outlines that a Final Report with major findings in all listed social domains be provided in the first year. Years 2 and 3 are intended to be Update reports, sharing significant trends experienced over the prior year and/or new data and research elements requested by the City.
