PROJECT DESCRIPTION/BACKGROUND

State Route 85 Monitoring Well

- Groundwater resources are limited and declining each year.
- A new, deeper well replacement is needed to replace MVV-6.
- Well installation is required for monitoring of new landfill cell.



SCOPE OF WORK / SERVICES

- The City of Phoenix SR-85 is an active landfill located at 28633 W Patterson Rd, Buckeye.
- Well will be installed up to 800 feet bgs with 5-inch PVC Schedule 80 casing.
- The well location is relatively flat and open, with minimal vegetation, and access roads.
- Mud rotary drilling is assumed.
- Water supply is available from a non-potable pond on-site.
- Mud must be containerized and disposed off-site.
- Well must be developed to a turbidity of 10 NTUs or less.
- Development water will be able to be disposed of to the ground at the well location. Hoses may be needed to direct the water to an appropriate disposal point.
- Project specifications will be available in the bid packet.


