However, under paragraph B. the SOW indicates the tanks will be swapped/replaced. Please clarify if tanks should be refilled or if spent tanks should be removed and replaced with a pre-filled resin tank?

2. **Question:** Section 3.1, paragraph B. The IFB indicates that Contractor's Bid should include transportation of used tanks to service location. However, the subsequent sentence in same paragraph indicates that costs for "Travel hours, equipment, fuel, etc.", are not permitted under this contract. Please clarify if Contractor can include all costs to transport tanks if off-site service is necessary?

3. **Question:** Please clarify the tank volumes and type of Resin used for each location listed under Section 3.7 of IFB. A review of provided part numbers does not always match a manufacturers tank offerings.

4. **Question:** Paragraph 3.3 of IFB list the City business hours as 6:00am to 5:00pm, however in Attachment B (price schedule sheet) standard hours are listed as 6:00am to 3:00pm, please clarify which is correct?
