### **REQUEST FOR QUALIFICATIONS**

The City of Phoenix is seeking two qualified consultants (one consultant team at each project site) to provide engineering services for design support, construction support and commissioning testing in support of multiple projects associated with electrical, inspection & control systems throughout the Val Vista and Lake Pleasant Water Treatment Plants. The Val Vista Water Treatment Plant project site is located at 3200 E. McDowell Road and Lake Pleasant Water Treatment Plant project site is located at 37000 N. New River Road. The estimated total construction cost for this project is \$7 million.

#### SECTION I – PROJECT DESCRIPTION

To improve the functionality, efficiency, and maintenance of the El&C systems, the City utilizes Electrical, Instrumentation & Control System Inspection and Testing Services to assist the Engineer and Contractor with projects related to the facility and its various systems. The City has developed El&C standards to provide consistency throughout the Water Services Department. Part of the selected consultants' role will be to ensure adherence to these standards on all projects during the design, construction, calibration, testing and commissioning of the El&C systems. In addition, the selected consultants will provide operations and maintenance support when City staff are replacing existing equipment or installing new equipment.

#### SECTION II - SCOPE OF WORK

All work performed is expected to be done in close coordination with City of Phoenix staff. The general scope of work includes providing design, construction, and commissioning support services for multiple rehabilitation or replacement projects at the Val Vista and Lake Pleasant Water Treatment Plants.

Design support services consist of providing technical support and consultations relative to installation techniques and procedures, ensuring adherence to the City standards, and ensuring adherence to applicable electrical codes. The selected firms will attend design meetings and project engineer demonstrations, support the Engineer with research of existing conditions, conduct design reviews of project plans and specifications, and support the Engineer with understanding the Water Service Department's standards for El&C systems. In addition, the selected firms may be required to support City staff in updating and maintaining the Water Services Department's standards as necessary.

Construction support services consist of reviewing equipment submittals, conducting reviews on the equipment installation, providing field observations reports, participating in factory testing, reviewing the completeness of required equipment testing documentation, and witnessing the instrumentation calibrations and loop checks.

Commissioning testing consist of providing assistance on computer control strategy checkout, tuning of control loops, performing loop tests, troubleshooting for the computer control system programmers, maintaining designated instruments through final acceptance, educating the plant staff on the systems, supporting the maintenance staff on developing maintenance procedures for designated equipment, and reviewing the accuracy of the as-built documentation for electrical drawings and the process and instrumentation diagrams.

The selected firms may be required to provide arc flash hazardous testing services utilizing a professional electrical engineer. The arc flash hazardous testing will include as-building existing single line diagrams, conducting load calculations for motor control centers, switchgear and power panels, and have the knowledge to conduct a power system study. The selected firms will be required to access energized equipment and provide all arc flash safety personal protective gear that meets the requirements of National Fire Protection Association.

The selected firms will be required to as-build existing control panels and have the ability to design control panels. The selected firms will be required to understand UL508 requirements.

The selected firms will be required to participate on the Water Services Department Process Controls Standards Committee and develop standards for this committee or participate in standards development; specialize in electrical engineering; have at least one Registered Professional Electrical Engineer, and a minimum of one Senior Instrumentation and Controls Technicians on staff.

The firms will be required to supply all the tools and test equipment necessary to perform the plants wide evaluation of major electrical equipment and for commissioning new and/or rehabilitated equipment. As such, the following is a list of services expected to be performed by the selected consultants on an as requested basis:

- Review contract documents including construction plans and specifications for adherence to current City standards.
- Attend meetings with City staff and JOC contractor(s) to discuss and coordinate design issues and review the work progress.
- Review and provide comments on shop drawing submittals.
- Perform inspection activities, including special inspections, start-up, Operations & Maintenance manual review,
- Represent the City's interest in construction related matters. This includes review of Maintenance of Plant Operation Plans to coordinate plant equipment and process shutdowns with the contractor's work during construction.
- At any given time, the contracted firm may have any number of projects in various stages of implementation and will be required to coordinate with City staff and the City's JOC contractor(s) on the status of these projects.

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

#### SECTION III - PRE-SUBMITTAL MEETING

A pre-submittal meeting will be held at 1:00 p.m., Phoenix time on Tuesday, May 7, 2024, at 200 W. Washington Street, City Hall Conference Room 8 East **AND** via Teams. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested firms attend the pre-submittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

- A maximum of 12 pages is permitted to address all content in the SOQ submittal. (Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)
- Submit electronically the Statement of Qualifications by 12:00 noon, Phoenix time, on Friday, May 17, 2024.
- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11".
- Font size must not be less than 10 point.
- Content count:
  - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
  - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
  - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.
- ☑ Information Sheet: Provide an information sheet that includes project title, project number, RFx number, legal firm name (not a trade name), address, phone number, vendor number, and the

name, title, email address and signature of your contact person for the project. Do not include any additional information.

- **Evaluation Criteria:** Address the SOQ evaluation criteria.
- Additional Content: Resumes and other information may be included (*content shall be included* within the permitted maximum page limit).

Note: All pages exceeding the specified maximum page limit will be removed from the submittal and not considered in evaluating a submitted SOQ.

#### SECTION VI - GROUNDS FOR DISQUALIFICATION

The following **will be grounds for disqualification**, and will be strictly enforced:

- Uploading of submittal to the wrong project.
- Violating the "Contact with City Employees" policy contained in this RFQ.

#### SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least three, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

The following tentative schedule has been prepared for this project.

If the City is unsuccessful in negotiating a contract with the best-qualified firms, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

All submitting firms will be notified of selection outcome for this project. The status of a selection on this project will be posted on the City of Phoenix's "Tabulations, Awards, and Recommendations" website:

The selected Consultant should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement's contract provisions.

#### SECTION VIII- GENERAL INFORMATION

**Citywide Capital Improvement Projects.** Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification. The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

**Alternate Format.** For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

**Release of Project Information/Public Records Request.** The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City. To submit a Public Records Request, visit <u>phoenix.gov/prr</u>.

**City Rights.** The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

**Contact with City Employees.** This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.** 

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

**Conflict of Interest.** The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

**Protest Procedures.** Firms responding to disqualification or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
