2.	Section 3 Scope of work 3.1. VEHICLE: The non-volatile portion for all types shall be composed of a 100% acrylic polymer as determined by infrared spectral analysis. The acrylic resin used for Type III shall be a 100% cross-linking acrylic as evidenced by infrared peaks at wavelengths 1568, 1624, and 1672 cm-1 with intensities equal to those produced by an acrylic resin known to be 100% cross-linking.	Section 3 3. – The department is requesting Type II Fast Dry Acrylic Waterborne Paint. They do not want the High Build.
