No.	Question	Answer
1.	Is the City accepting alternative brands?	Yes, when preferred brands are not available.
2.	On the Submittal Form there is a City of Phoenix Sales Tax No. and Arizona Corporation Commission File No. are those required? We are a California based company. If required can you direct me to the right place to get the process started?	Complete as may fields as possible. Per 2.9, you must be registered to do business in Arizona.
3.	Should bid offer be submitted on the of June 5, 2024 or can it be submitted earlier?	It can be submitted earlier, but ensure all addenda are submitted with your offer as well, per 2.8.
4.	Our offer has a service component that is a bit unique which we believe will benefit the city greatly. Are we able to attach that information in the bid submission e-mail for additional consideration?	Yes, you can attach the information for consideration.
5.	Can I please confirm that we would fall under Group B per the Scope of Work section? Our company offers solid industrial tires for heavy equipment.	Yes.
6.	What does it mean when a company has been awarded the bid for five years? Does it mean that we will be the exclusive solid tire supplier to the city during this contract terms or does it mean we are the primary? If primary does that mean the city will award a specific PO to other suppliers based on the sole discretion of the purchaser for the city?	Our contracts provide an initial three-year term with two option years at the department's discretion. The city may exercise a multi-award contract, with no exclusive or primary designation.
7.	We checked the purchase order history for City of Phoenix, and we noticed the City buys BRM retreads. Instead of removing BRM2 line items, can it be updated to just the BRM?	Yes, we can change it to BRM. These tires will be used for the street and alley use. – Please See Revised Bid Price Schedule
8.	Group C you have listed Bandag BRM2, but this has been discontinued by the manufacturer 2 years ago. Only BRM & BRM3 are available	Yes, we will change this to BRM and BRM3. – Please See Revised Bid Price Schedule
