REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified consultant team to provide Engineering Services for the Dobbins Road widening project from State Route 202 Loop to 27th Avenue. Services will include preliminary and final design. The estimated construction cost is \$36.5 million.

SECTION I - PROJECT DESCRIPTION

The project will widen Dobbins Road roadway to cross section Z-C "scenic corridor" configuration - four through travel lanes. The work will include a 74-foot width of pavement and a multi-use path with active transportation opportunities. Infrastructure work will include a storm drain, traffic signal, landscaping and SRP power, and irrigation relocation are anticipated.

The City has created a public web page to provide information to interested consultants regarding the upcoming Dobbins Road project. The web page includes the previous studies completed by the City of Phoenix and MAG. The project is currently scheduled to be advertised in May.

SECTION II - SCOPE OF WORK

The scope of work will include roadway widening; multi-use path (MUP) and active transportation features; traffic analysis and design including signal or roundabout design, signing, striping, and streetlights; drainage analysis and design; geotechnical analysis and recommendations; transit route design; utility relocations; landscape architecture; aesthetics/art; right-of-way determination; public outreach; environmental coordination; and other tasks as determined by the project needs. The design scope will be split into two main tasks: Preliminary Engineering (PE) and Final Design (FD). Preliminary engineering will consist of all technical analysis and engineering required to progress the project through final design expeditiously by addressing all critical path items, such as right-of-way, environmental, traffic and intersection analysis, public meetings, and aesthetic concepts. The following scope outlines the project including PE and FD. Scope is included, but not limited to:

Roadway widening: The consultant will perform geometric design and 3D modeling of the corridor to ensure a consistent City of Phoenix standard section "C" within the limits. 3D modeling will be utilized to ensure compliance with PROWAG at intersections and driveways as well as other reasons such as quantity calculations.

Active Transportation features will include designing a continuous multi-use path along the corridor. Currently the path is discontinuous and lacks adequate rights-of-way. The selected team may be challenged to fit all the amenities within the available footprint.

Traffic analysis may consist of warrant analysis and updated traffic modeling using the MAG Laveen model (if required). With the community desiring to maintain the rural feel of the roadway, alternatives to signalized intersections can be evaluated if costs and property takes are reasonable. Depending on the results of the warrant analysis and intersection alternative analysis, the consultant will design signals, provide signing, striping, and streetlight plans. Vision Zero is important to the city and incorporating added safety features into the project can be evaluated.

Transit route planning: The project will incorporate transit planning such as bus stops and shade structures into a proposed new transit route along Dobbins Road.

On-site and off-site **drainage analysis** will be required. Dobbins Road experiences regular flooding along this corridor in locations. Predetermined onsite outfall locations have not been established along the entire corridor. Therefore, offsite runoff may pose significant challenges to the project. In addition, two

projects from the Laveen Area Drainage Master Study that are funded with the GO Bonds will need to be coordinated with.

Extensive **utility relocations** will be required by the project to include coordination with SRP distribution, transmission, and irrigation. Additional wet and dry relocations are also anticipated. The city will facilitate most of the relocation and utility coordination efforts. The consultant will create a base map, provide pothole lists, attend meetings, address review comments, and design any city of Phoenix owned relocation such as fire hydrant or sanitary sewer.

Public outreach and stakeholder coordination will be required with this project. The City will hire a public outreach firm through their on-call contract. The consultant will be required to provide exhibits, artistic renderings, presentations, and attend and present at the public meeting. Two public meetings will be planned in preliminary design and two in final design. The consultant will be required to coordinate with primary stakeholders including the county and the Laveen Village Planning Committee.

Landscape architecture will be an important component along the MUP and within the right-of-way. The consultant will prepare landscape concepts and plans.

Aesthetics and Art will be incorporated into the project. The city will hire an artist to work with the consultant team. The community wishes to maintain the rural look and feel and promote the South Mountain views. The art features can be incorporated into both vehicle and MUP travel.

Geotechnical investigation and analysis provided by the consultant includes, but is not limited to, determining pavement section, storm drain boring and/or retention basin percolation tests.

Right-of-way acquisition will be required. The consultant will determine right-of-way needs during PE phase and acquisitions will be completed by the city and/or county during FD.

Environmental work may be completed by city staff and minimal amount of coordination will be required by the consultant.

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

SECTION III - PRE-SUBMITTAL MEETING

A pre-submittal meeting will be held at 1:00 p.m., Phoenix time on Friday, June 28, 2024, at 200 W. Washington Street, City Hall 5TH Floor, 5 West Conference Room. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested firms attend the pre-submittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

SECTION IV - STATEMENT OF QUALIFICATIONS EVALUATION CRITERIA

A Firm will be selected through a qualifications-based selection process based on the criteria below. Subcriteria are listed in order of importance in relation to project services. City of Phoenix project experience is not required.

A. Design Experience of the Prime Firm (maximum 50 points)

Describe the experience and qualifications of the prime firm in providing design services for similar projects. Identify projects the submitting firm has completed. For each project listed, provide:

- 1. Description of the project including scope and project owner
- 2. Role of the firm and explain how this relates to the services being solicited
- 3. Project's original contract value, final contract value, and reason for variance
- 4. Project's start date and completion date

B. Design Experience of the Key Personnel and Subconsultants (maximum 50 points)

Describe the experience and qualifications of the specific project team expected to be assigned to this project in providing design services for similar projects. For each key person identified, list their length of time with the firm. List each key person's role in the projects provided. If a project selected for a key person is the same as one selected for the firm, provide just the project name and the role of the key person. For each project listed, provide:

- 1. Description of the project including scope and project owner
- 2. Role of the team or team member and explain how this relates to the services being solicited
- 3. Project's original contract value, final contract value, and reason for variance
- 4. Project's start date and completion date

C. Project Understanding and Approach (maximum 250 points)

Describe your firm's understanding of the City's needs for this project, including important considerations such as project issues and challenges of each segment. Describe the team's approach to the project, including important considerations such as scope, schedule, and budget.

- 1. Describe the team's understanding of the project constraints and the approach to overcome them.
- 2. Describe the team's approach to preliminary engineering design. Describe the approach to identifying risks and avoiding delays in final design.
- 3. Provide a case study that successfully incorporated value engineering into the design for a project that had competing agendas and interests and potential for scope creep and runaway costs.
- 4. Describe what steps and actions each of your key personnel will take to ensure quality control on each submittal, including submissions from subconsultants.

D. Staffing Information for Key Personnel (maximum 50 points)

Provide the following:

- 1. Team's availability and commitment to the project, including subconsultants
- 2. Team's plan to maintain continuity of the proposed services
- Organization chart showing key personnel, current professional licenses or certifications, and assigned roles for both Design and Construction Administration and Inspection Services for the project
- 4. Identify the location of the lead firm's principal office and the home office location of key staff on this project

E. Reference Check (maximum 21 points*)

Use the form provided (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

SECTION V - SUBMITTAL REQUIREMENTS

New Electronic Submittal Process: Firms interested in this project must submit a Statement of Qualifications (SOQ) electronically via email to the Contracts Specialist, Kathleen Kennedy at kathleen.kennedy@phoenix.gov.

Submittal requirements are as follows:

☑ Vendor Information: All firms must be registered in the City's Vendor Management System prior to submitting a proposal. - Submittals must be <u>emailed</u> to the assigned Contracts Specialist by the submittal due date and time.
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name (full legal name), vendor number, project title, and project number on the cover of the SOQ.
- A maximum of 14 pages is permitted to address all content in the SOQ submittal. (Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)
- Submit electronically the Statement of Qualifications by 12:00 noon, Phoenix time, on Friday, July 19, 2024.
- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11".
- Font size must not be less than 10 point.
- Content count:
 - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
 - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
 - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.
- ☑ **Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, **legal firm name (not a trade name)**, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. SECTION VI – GROUNDS FOR DISQUALIFICATION

The following will be grounds for disqualification, and will be strictly enforced:

- Submitting the SOQ to the assigned Contracts Specialist after the submittal due date and time.
- Violating the "Contact with City Employees" policy contained in this RFQ.

SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

Finalists from the SOQ evaluation will be invited to participate in detailed interviews. A letter to each finalist will contain the evaluation criteria to be used during the interview presentation. Interview evaluations to select the highest qualified firm include scores from the SOQ evaluation process. The City may conduct a due diligence review on the firm(s) receiving the highest evaluation.

The City expects to create a final list of at least two, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

SECTION VIII - GENERAL INFORMATION

Citywide Capital Improvement Projects. Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification. The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

Alternate Format. For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

Release of Project Information/Public Records Request. The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City. To submit a Public Records Request, visit phoenix.gov/prr.

City Rights. The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

Contact with City Employees. This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.**

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

Conflict of Interest. The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

Protest Procedures. Firms responding to disqualification, or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
