REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified Construction Manager at Risk (CMAR) to provide preconstruction services and complete construction services for the SROG 91st Avenue Wastewater Treatment Plant, Plant 1A Rehabilitation project. The selected CMAR will work as a team with the designer of record and City staff to ensure an efficient design approach for the project. The project is located at the 91st Avenue Wastewater Treatment Plant. The estimated construction cost is \$50 million.

SECTION I - PROJECT DESCRIPTION

The 91st Avenue Wastewater Treatment Plant (WWTP) is located on a 560-acre site just east of 91st Avenue, south of Broadway Road and north of Southern Avenue. The plant is owned by the Sub-Regional Operating Group (SROG) and operated by the City of Phoenix. The facility has the capacity to treat 230 million gallons per day (MGD). Portions of the facility were built in the early 1960's, and the facility has been expanded and modified since. The facility treats the wastewater with various processes consisting of:

- Screening
- Grit removal
- Primary sedimentation
- Activated sludge with nitrification-denitrification
- Secondary Sedimentation
- Disinfection by chlorine
- Dechlorination (sodium bisulfite)

Both primary and secondary solids are thickened using centrifuges in the Solids Thickening Facility prior to digestion in sixteen anaerobic digesters using multi-phase digestion. Solids are fed to an acid-phase digester then to multiple methane phase digesters. Digested sludge is dewatered using centrifuges in the Solids Handling Facility and then hauled off-site for land application.

This project will include the rehabilitation or replacement of assets throughout the Plant 1A treatment train, and may include, but are not limited to:

- Primary Sedimentation
 - Control Gates
 - o Basins
 - Clarifier equipment
 - Pumps, valves, and controls
 - o Piping
 - Instrumentation
- Aeration
 - o Basins
 - o Blowers
 - Aeration piping, valves and controls
 - Aeration domes
 - IMLR pumps and controls
 - Instrumentation
- Secondary Sedimentation
 - Control Gates

- Basins
- Clarifier equipment
- o Pumps, valves, and controls
- Piping
- Instrumentation

In addition to the above items, other assets within the Plant 1A treatment train include other pumps, motors, piping, valves, control instruments, control panels, and electrical equipment including panels, variable frequency drives, transformers, motor control centers, and process control equipment such as programmable logic controllers (PLCs) necessary for the operation of Plant 1A.

It is anticipated the design and construction necessary to complete the project scope will occur over multiple fiscal years with multiple design, construction, equipment procurement and equipment installation packages being required.

SECTION II - SCOPE OF WORK

The Construction Manager at Risk will begin with the firm in an agency support role for preconstruction services. The CMAR will assume the risk of delivering the project through a Guaranteed Maximum Price (GMP) contract. The CMAR will be responsible for construction means and methods, and will be required to solicit bids from prequalified subcontractors to perform the work using the City's subcontractor selection process. The CMAR may also compete to self-perform limited amounts of work. The GMP must be submitted in MAG or CSI format or it will not be accepted.

- A. Preconstruction phase services by the CMAR may include the following:
 - provide detailed cost estimating and knowledge of marketplace conditions.
 - provide project planning, design review and scheduling.
 - provide for construction phasing and scheduling that will minimize interruption to City operations.
 - provide alternate systems evaluation and constructability studies.
 - advise City on ways to gain efficiencies in project delivery.
 - provide long-lead procurement studies and initiate procurement of long-lead items.
 - assist in the permitting processes.
 - participate with the City in a process to set a goal for local and SBE participation and implement the local and SBE process.
 - protect the City's sensitivity to quality, safety, and environmental factors.
 - advise City on choosing green building materials.
 - Assist with life-cycle cost analyses to provide recommendations for replacement equipment.
 - With City engineering, operations, maintenance staff, and the design/CA&I firm, participate in field review(s) of the equipment, facilities and systems identified in the 91st Avenue WWTP Facility Assessment in the Plant 1A area to be rehabilitated or replaced.
 - Prior to site visits, the Engineer shall coordinate with the CMAR to identify any needs for logistical assistance in the condition assessment work, such as providing scaffolding or other measures for equipment access, assistance in moving or operating equipment, and coordination with vendors and suppliers whose involvement may be needed.

- This effort should identify the work site's specific location and identify factors such as accessibility, constructability limitations, existing facilities, regulatory factors, etc., that are important considerations to the Project.
- With City engineering, operations, maintenance staff, and the design firm, identify the scope, level and detail of construction drawings necessary to accomplish the project objectives.
- With City engineering, operations and maintenance staff, and the design firm, develop an
 initial schedule for the rehabilitation and replacement of the assets. Schedule shall be
 prioritized based on the results of the field reviews(s), shall include and be cognizant of
 plant operations and maintenance schedules.

B. Construction phase services by the CMAR may include:

- Provide the necessary services for the replacement or rehabilitation of the equipment and systems per design plans and specifications.
- Select subcontractors/suppliers for this project.
- Prepare a Guaranteed Maximum Price (GMP) proposal that meets the approval of the City.
- Coordinate with various City of Phoenix departments, other agencies, utility companies, etc.
- Arrange for procurement of materials and equipment.
- Schedule and manage site operations.
- Bid, award, and manage all construction related contracts while meeting City bid requirements including the local and SBE participation goal.
- Provide quality controls.
- Bond and insure the construction.
- Address all federal, state and local permitting requirements.
- Deal with Owner issues.
- Maintain a safe work site for all project participants.
- The CMAR will be required to maintain all project records in electronic format.
- The CMAR shall provide a computerized networked office platform with broadband internet connectivity.
- With City engineering, operations, maintenance staff, and the design/CA&I firm, insure
 the rehabilitated or replaced assets are tagged per City requirements, and provide to the
 WAM Core Team the necessary information regarding rehabilitated or replaced assets to
 insure the completeness of the WAM system.
- With City engineering, operations, maintenance staff, and the design/CA&I firm, assist
 with the development of necessary maintenance of plant operations plans in order to
 avoid disruption of the treatment process.
- Provide operations and maintenance manuals for new equipment and insure their completeness and adherence to City standards and requirements.
- Provide start-up assistance.
- Provide training services as required.
- Provide commissioning services.
- Prepare and review project documents (e.g. correspondence, schedules, submittals, shop drawings, test data, project data, progress payments, change orders, as-built drawings, etc.)

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The CMAR will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the CMAR will be required to utilize in the fulfillment of the contract requirements.
- The CMAR shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

SECTION III - SMALL BUSINESS ENTERPRISE (SBE) REQUIREMENTS

Only firms whose physical business is located within Maricopa County are eligible to meet the SBE subcontracting goal, which will be set prior to construction of this project. The final goal will be based on SBE subcontractor availability.

SECTION IV - PRE-SUBMITTAL MEETING

A pre-submittal meeting for design and CMAR services will be held at 9:00 a.m., Phoenix time on Wednesday, October 2, 2024, at 200 W. Washington Street, 9th floor Training Room. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested firms attend the presubmittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

SECTION V - STATEMENT OF QUALIFICATIONS EVALUATION CRITERIA

One firm will be selected through a qualifications-based selection process based on the criteria below. Subcriteria are listed in order of importance in relation to project services. City of Phoenix project experience is not required.

A. General Information (150 points)

- 1. Provide a general description of the firm that is proposing to provide construction management services and general construction services. Explain the legal organization of the proposed firm or team. Provide an organization chart showing key personnel.
- 2. Provide the following information:
 - a. List the Arizona contractor licenses held by the firm and the key personnel who will be assigned to this project. Provide the contractor license number. Reference the appropriate licenses held, if needed. In order to be considered for this project, the contractor must hold the correct license as deemed appropriate by the Arizona Registrar of Contractors prior to submitting a Statement of Qualifications (SOQ) for this project in accordance with Arizona Revised Statute §32-1151.
 - b. Identify the location of the firm's principal office and the home office location of key staff on this project.
 - c. Identify any contract or subcontract held by the firm or officers of the firm, which has been terminated within the last five years. Identify any claims arising from a contract

which resulted in litigation or arbitration within the last three years. Briefly describe the circumstances and the outcomes.

B. Experience and Qualifications of the Firm (250 points)

- Identify at least three comparable projects in which the firm served as either CMAR, agency Construction Manager during design and construction phases (without providing construction services), or General Contractor. Special consideration will be given to firms that have provided Construction Manager at Risk services on similar successful projects. For each project identified, provide the following:

- 2. List any proposed consultants, including key staff names and the experience and qualifications of these individuals.

D. Understanding of the Project and Approach to Performing the Required Services (350 points)

- 1. Discuss the major issues your firm has identified on this project and how you intend to address those issues.
- Attached to this Request for Qualifications is the City of Phoenix general subcontractor selection plan (see Exhibit A). Describe how you intend to implement this subcontractor selection plan including your recommendations for subcontractor trades to be selected by qualifications only vs. qualifications and bids; and discuss the benefit that your subcontractor selection plan provides to the project.

- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name, vendor number, project title, and project number on the cover of the SOQ.
- A maximum of 12 pages is permitted to address all content in the SOQ submittal (Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)
- Submit the Statement of Qualifications by 12:00 noon, local time, on Friday, October 11. 2024.
- Page size must still meet requirements of 8½" x 11"
- Font size must not be less than 10 point

- Content count:
 - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
 - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
 - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.

GROUNDS FOR DISQUALIFICATION:

Please be advised that the following **will be grounds for disqualification**, and will be strictly enforced:

- Violating the "Contact with City Employees" policy contained in this RFQ.
- Failure to provide bonding statement.

SECTION VII - SELECTION PROCESS AND SCHEDULE

The successful firm will be selected through a qualifications-based selection process. Interested firms will submit a Statement of Qualifications (SOQ). A Selection Panel will evaluate each SOQ according to the criteria set forth in Section V above. The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least one, but not more than three firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of contract terms for City Council approval.

The following tentative schedule has been prepared for this project. The Pre-submittal meeting is not mandatory.

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

The firm selected for this project will be notified directly by the City. Notification to all other firms on the status of a selection on this project will be posted on the City of Phoenix's "Tabulations, Awards, and Recommendations" website:

The selected Contractor should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement's contract provisions.

SECTION VIII - GENERAL INFORMATION

Citywide Capital Improvement Projects. Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. Any changes to this Request for Qualifications will be in the form of a notification. The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Solicitations and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if notifications have been issued. Registered RFQ holders may refer to the webpage or call the Contract Specialist (listed below) in order to ascertain if a Notification has been issued for this project.

Release of Project Information/Public Records Request. The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. City Rights. The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

Contact with City Employees. Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the

designated Contract Specialist), including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

Conflict of Interest. The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

Protest Procedures. Firms wishing to respond to disqualification or a procurement outcome may refer to The Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process. EXHIBIT A CITY OF PHOENIX SUBCONTRACTOR SELECTION PLAN (EXCERPT FROM CMAR CONTRACT)

MAJOR SUBCONTRACTOR AND MAJOR SUPPLIER SELECTIONS

The selection of major Subcontractors and Suppliers may occur before Construction Services. Major Subcontractors and Suppliers may be selected based on qualifications alone or a combination of qualifications and price. Subcontractors must not be selected based on price alone. The selection of major Subcontractors and Suppliers is the Contractor's responsibility. In any case, the Contractor is solely responsible for the performance of all selected Subcontractors and Suppliers.

The Contractor must prepare a Subcontractor and Supplier selection plan and submit the plan to the City for approval. This selection plan must identify trades that may be selected by qualifications only and trades that to be selected by qualifications and competitive bid. This plan must also identify all Subcontractors that are not selected through a formalized qualifications-based selection process. The Subcontractor and Supplier selection plan must be consistent with the selection requirements included in this Contract.

<u>Selection by qualifications only</u> - the City may approve the selection of a Subcontractor(s) or Suppliers(s) based only on their qualifications when the Contractor can demonstrate it is in the best interest of the Project.

Qualification-based selection of a Subcontractor(s) or Supplier(s) should only occur during the design phase to achieve maximum benefit of Subcontractor's involvement before submittal of a GMP Proposal.

The Contractor must follow the approved Subcontractor selection plan when evaluating qualifications of Subcontractor(s) or Supplier(s), and the Contractor must provide the City with its review and recommendation.

The Contractor must receive City approval of the selected Subcontractor(s) and Supplier(s).

The Contractor must negotiate costs for services/supplies from each Subcontractor and Supplier selected under this method.

<u>Selection by qualifications and competitive bid</u> - the Contractor must follow the Subcontractor selection plan when evaluating qualifications of a Subcontractor or Supplier, and the Contractor must provide the City with its process to prequalify prospective Subcontractors and Suppliers. During Construction Services, all Work for major Subcontractors and Suppliers must then be competitively bid unless a Subcontractor or Supplier was selected by qualifications only.
