

## **SBE Program Requirements**

The City of Phoenix strives to advance the economic growth of businesses through its Small Business Enterprise (SBE) Program.

The City encourages the participation of SBE firms throughout all phases of contracts.

Subject to City of Phoenix Code, Chapter 18, Article VI, pertaining to the participation of Small Business Enterprise (SBE) firms.

## **SBE Program Requirements**

The City of Phoenix SBE Goals Committee has established an SBE participation goal of <u>7%</u> for this contract.

The successful submitter is required to meet or exceed the required SBE Goal for ALL work performed on the construction contract.

The Prime Contractor is required to demonstrate good faith efforts to utilize certified SBE firms to achieve this goal during the life of this contract.

# Project Background

Lift Station 40 is located at 5102 E Ray Road

The lift station is a wet pit/dry pit facility that conveys wastewater via force main ~3.1 miles north to a gravity sewer in Guadalupe Road

Current capacity is ~13 MGD. The existing four sewage pumps cannot be operated at full speed due to inadequate net positive suction head available (NPSHA) and are in need of replacement due to age. In addition, the wet well does not provide adequate storage capacity and/or operational flexibility and flows often back-up into influent gravity sewer.

The City recently completed a hydraulic and process control study (Lift Station 40 Study and Analysis) which recommended several alternatives including construction of a new wet well with increased storage volume.

This rehabilitation project includes the design of a new wet well, discharge piping, force mains, influent gravity sewer relocation, and miscellaneous site improvements.


Due to its criticality in the City's wastewater conveyance system, the station is required to maintain facility operations during the construction process.




Project includes decommissioning and demolition of existing facilities.

### Scope of Work / Services

- The Lift Station 40 Rehabilitation project includes the construction of the following items:
  - Influent Gravity Sewer Pipe and Manhole Structures
  - Wet Well
  - Discharge Manifold Piping
  - Force Mains with Pig Launching Structures
  - Biofilter System
  - Ferrous Chloride Odor Control Station
  - Electrical Building
  - Generator
  - Electrical Equipment: Service Entrance Sections, Transformers, ATS Switch, etc.
  - Site Improvements: CMU Wall, Access Gates, Equipment Pads, AC Pavement, etc.
  - Coordination with SRP for new electrical feed and service.
