

ADDENDUM 3

- I. **Written Inquiries.** In response to Offerors' written inquiries in accordance with the Solicitation's **Section 2.8 ("Inquiries")**, the City of Phoenix ("**City**") provides answers to those inquiries below.

QUESTIONS AND ANSWERS:

Note: Spelling, grammar, and punctuation of the questions are shown exactly as submitted by the potential respondents.

No.	Question	City's Response
1.	I have recently reviewed the details of Tender No. PTD24-008 and could not find any mention of an Earnest Money Deposit (EMD) or any other deposit requirements associated with the tender. Could you kindly confirm whether there is a deposit requirement for this tender or not?	There is no bid/solicitation bond or security, or other deposit, required from offerors under this Solicitation.
2.	Can you advise what is the service period? Group 2?	Under the Solicitation's Sections 3.1 and Addendum No. 2, Section I, Subsection D, 3.1.2 and Subsection G, 3.3.2, the term of the contract for Group 2 will be an initial three-year contract term (with deliveries to begin partway into the first year), plus two optional one-year extensions. The City anticipates the Contract for Group 2 services to commence in or around February 2025, with deliveries anticipated to begin about two months after contract commencement once the Group 1 Contractor installs the leased 120V gaseous mobile fueler.
3.	To ensure we get all the pertaining information, how will we find out or get notified if there is an addendum?	As with previous addenda, Public Transit Procurement will send an email notice to all potential offerors, which will include the link to the City's public solicitation website where the addendum is posted. Of course, potential offerors can review this website at any time to check for posted addenda (see solicitationsadmin.phoenix.gov/Solicitation/Details/1946).
4.	Can you confirm for us what is the ship to address?	Under Solicitation Section, 6.2, the "ship to" address for Group 2 hydrogen fuel deliveries is the City's West Operating Facility located at 405 N. 79 th Ave, Phoenix, AZ 85043.
5.	We noticed this bid was pushed out from 11/12 to 12/19, will there be another pre-bid meeting that we can attend to?	No. The City has no plans to schedule another pre-offer meeting; however, a PowerPoint document from the original pre-offer meeting is available on the public solicitation site (see link in answer to Question No. 3 above). Please note that this document does not reference the revisions in Addenda Nos. 1 and 2, which were posted after the original pre-offer meeting.
6.	Is this still open for Bid for both the equipment and H2 product?	Yes. Addendum No. 2 extended the Offer Due Date to December 19, 2024, which applies to offers for both Groups 1 and 2.



7.	Are you set in stone on Liquid vs Gas?	<p>Yes. Under Addendum No. 2, Section I, Subsections F and G, which revise Solicitation Sections 3.3.1 and 3.3.2 to require the Group 2 Contractor's supply of gaseous hydrogen for the Group 1 Contractor's leased 120V gaseous-hydrogen mobile fueler until the Group 1 Contractor has installed a liquid-hydrogen mobile fueling station, which will require the Group 2 Contractor's supply of liquid hydrogen.</p> <p>Please note that the Group 2 Contractor must also supply liquid or gaseous hydrogen, depending on the Group 1 Contractor's temporarily provided on-site fueling solution in the event that the liquid-hydrogen mobile fueling station is non-operational for a period of more than 24 hours.</p>
