REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified consultant team to provide Engineering services for the North Valley Parkway and Sonoran Wash Bridge project. Services will include final design, and possible construction administration and inspection services. This project is located across the Sonoran Wash that aligns with North Valley Parkway between Dixileta Drive and Rancho Tierra Drive. The estimated construction cost is \$29 million.

SECTION I – PROJECT DESCRIPTION

The scope of the North Valley Parkway and Sonoran Wash Bridge project will consist of construction of roadway improvements along North Valley Parkway between Dixileta Drive and Rancho Tierra Drive, including a vehicular bridge across the Sonoran Wash, giving commuters an all-weather roadway. The final design will be developed in collaboration with a Construction Manager at Risk.

SECTION II - SCOPE OF WORK

The scope of the project is to construct the improvements along North Valley Parkway. In addition to the bridge, half street improvements along the east side of North Valley Parkway required. The improvements include, but not limited to, additional travel lanes, bicycle lanes, pedestrian improvements, and medians.

A Project Assessment to establish a preferred alternative for an all-weather crossing for the Sonoran Wash was completed June 2021.

The Project Assessment for North Valley Parkway & Sonoran Wash Bridge (June 2021), including the 15% Conceptual Plans and other information are available for download at:

The Project Assessment includes a preferred bridge alternative, and the City has decided to pursue a design that meets the parameters outlined by Alternative A – Structure to Span the Floodway (short bridge).

This phase of the project will build on the Project Assessment. The consultant team will be responsible for general project administration, pre-design phase (30%), design development phase (60%, 90% and 100%), commissioning, cost estimates, construction documents and specifications, geotechnical investigations, hydraulic analysis model, technical reports, and coordination with a Construction Manager at Risk contractor for constructability reviews to produce the contract documents for construction, and include possible construction administration and inspection services.

It is anticipated that this project will be implemented through a Construction Manager at Risk (CMAR) Contract.

Design services shall include, but are not limited to:

- Design and prepare project plans and specifications for the construction of the project
- Conduct geotechnical engineering and investigations of project site
- Investigate and design utilities and infrastructure for project development (including, but not limited to water, sewer, storm water and coordinate with utility agencies)
- Coordinate tasks with various stakeholders including the City Environmental and Right of Way teams for permitting requirements
- Provide cost estimates for the project to be constructed
- Work with stakeholders from various agencies as required
- Coordinate with CMAR in developing design documents
- Review of and recommendations regarding cost models/GMPs provided by the CMAR contractor
- Assist in value engineering process
- Participate in City coordinated public information and community outreach as required

Other services as required to support successful completion of the work and the City's interests

Possible Construction Administration and Inspection (CA&I) services shall include, but are not limited to:

- Provide general project construction administration and inspection services to ensure compliance with the project plans and specifications
- Develop project schedule with the Contractor
- Provide daily interaction with contractor to clarify job requirements
- Hold on-site and off-site meetings as appropriate with Contractor, City staff, impacted third parties, utilities, and agencies as required
- Assist with or conduct construction meetings
- Review contractor shop drawings and submittals
- Review and certification of monthly progress payments
- Review and approve monthly pay requests
- Schedule, conduct and provide documentation for regular progress meetings with client
- Respond to Request for Information and Change Order requests (issue interpretations and clarifications of the construction documents)
- Verify compliance with contract documents
- Prepare weekly observation reports detailing construction progress to keep City informed of project status and issues
- Perform record keeping and maintain project documents including correspondence, schedules, submittals, test data, payments, meeting minutes, specifications, drawings, photographs, shop drawing, as-builds, etc.
- Conduct Substantial Completion walkthrough
- Issue recommendation for Substantial Completion
- Review contractor's record drawings monthly and prepare final record drawings
- Punch-list development
- Conduct pre-final and final walkthrough
- Conduct one-year warranty walkthrough
- Other services as required to support successful completion of the work and the City's interests

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

SECTION III - PRE-SUBMITTAL MEETING

A pre-submittal meeting will be held at 10:00 a.m., Phoenix time on Monday, December 2, 2024, at 1034 E. Madison Street, Street Transportation Department Design and Construction Management Division, Gecko Conference Room **AND** via TEAMS. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested firms attend the pre-submittal meeting. G. Reference Check (maximum 21 points*)

Use the form provided (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

*These points are in addition to the 1,000 points for the SOQ.

SECTION V - SUBMITTAL REQUIREMENTS

New Electronic Submittal Process: Firms interested in this project must submit a Statement of Qualifications (SOQ) electronically via email to the Contracts Specialist, Bobbie Hobart at bobbie.hobart@phoenix.gov.

Submittal requirements are as follows:

☑ Vendor Information: All firms must be registered in the City's Vendor Management System prior to submitting a proposal. - Submittals must be <u>emailed</u> to the assigned Contracts Specialist by the submittal due date and time
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name, vendor number, project title, and project number on the cover of the SOQ.

- A maximum of 14 pages is permitted to address all content in the SOQ submittal. (Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)
- Submit electronically the Statement of Qualifications by 12:00 noon, Phoenix time, on Friday,
 December 13, 2024.
- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11".
- Font size must not be less than 10 point.
- Content count:
 - Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
 - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
 - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.
- ☑ **Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, **legal firm name (not a trade name)**, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. Do not include any additional information.
- ☑ Evaluation Criteria: Address the SOQ evaluation criteria.
- ☑ **Additional Content:** Resumes and other information may be included (*content shall be included within the permitted maximum page limit*).

Note: All pages exceeding the specified maximum page limit will be removed from the submittal and not considered in evaluating a submitted SOQ.

SECTION VI – GROUNDS FOR DISQUALIFICATION

The following will be grounds for disqualification, and will be strictly enforced:

- Submitting the SOQ to the assigned Contracts Specialist after the submittal due date and time.
- Violating the "Contact with City Employees" policy contained in this RFQ.

SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least three, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

All submitting firms will be notified of selection outcome for this project. The status of a selection on this project will be posted on the City of Phoenix's "Tabulations, Awards, and Recommendations" website:

The selected Consultant should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement's contract provisions.

SECTION VIII – GENERAL INFORMATION

Citywide Capital Improvement Projects. Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification. The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

Alternate Format. For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

Release of Project Information/Public Records Request. The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City. To submit a Public Records Request, visit phoenix.gov/prr.

City Rights. The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

Contact with City Employees. This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.**

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

Conflict of Interest. The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

Protest Procedures. Firms responding to disqualification or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
