### REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified consultant team to provide engineering services for the 2024 Booster Pump Station Improvements project. Services include final assessment, design, and possible construction administration and inspection. This project site is at various locations throughout Phoenix, Tempe, and Paradise Valley. The estimated total construction cost for this project is \$20 million.

#### SECTION I - PROJECT DESCRIPTION

The City currently owns and operates approximately 112 Booster Pump Station (BPS) Facilities. In October 2017, the City completed a high level BPS Assessment as part of the Asset Data Collection effort. The project included a detailed condition assessment review of all BPS, including summarizing and prioritizing the BPS Facilities for rehabilitation and/or replacement as part of capital improvement projects (CIP) over the next several years. The proposed project includes rehabilitation design and improvements of four (4) BPS deemed critical for the operation of the water distribution system. The rehabilitation design of each facility includes, but is not limited to, the following improvements:

5J-B2 (Location: 6327 E Hummingbird Lane)

Firm Capacity: 50 GPM

Improvements: Complete rebuild. Includes site security, mechanical, structural, civil, electrical and I&C

upgrades.

2G-B2 (Location: 9475 North 26th Street)

Firm Capacity: 700 GPM

Improvements: Complete rebuild. Includes site security, mechanical, structural, civil, electrical and I&C

upgrades.

2A-B4 (Location: 526 E Bethany Home Road)

Firm Capacity: 3120 GPM

Improvements: Needs assessment. Site expansion. Electrical upgrades.

1-B4 (Location: 1790 E Rio Salado Parkway)

Firm Capacity: 27,800 GPM

Improvements: Needs to add additional pump/motor with VFD and electrical to site.

#### SECTION II - SCOPE OF WORK

The Design scope for each BPS includes, but is not limited to:

- Data collection and final assessment, including geotechnical and soil corrosivity investigation and coordination with City's Asset Management team.
- Hydraulic and transient modeling analysis for each station.
- Design services for civil, mechanical, structural, architectural, electrical and I&C for the refurbishment project which includes preliminary and final basis of design report, 30%, 60%, 90% and for construction design plans and specifications.
- Develop opinion of probable construction cost at various milestones.
- Coordinate with various utilities, permitting and regulatory agencies as required for obtaining necessary permits.
- Coordinate with Operations for planned shutdown and attend City shut-down operational meetings, as required.
- Coordinate with CMAR during design development, including assisting with GMP development, review and preparing recommendation for the City.
- Assist with public outreach if required.

The Construction Administration and Inspection (CA&I) services scope for this project will include, but is not limited to:

Assist the City in obtaining permits and approvals for the work.

- Provide oversight of the project construction activities to ensure protection against defects and deficiencies in the work of contractors, their subcontractors and sub consultants.
- Inspect the site through various stages of construction to inspect the quality of the executed work and to verify the work is in accordance with construction documents and specifications.
- Confirm contractors' work progress and qualities of work completed.
- Review contractor cost proposals, submittals, shop drawings, requests for information (RFIs), payment applications, change orders, etc., as directed by the City.
- Perform field inspections (visual, probe, and testing) where required for completed repairs and reject work not conforming to project documents and specifications.
- Provide weekly field reports with associated photos/videos of observations and tests performed.
- Attend and/or conduct project-related design and construction progress meetings.
- Prepare punch list of corrective work to be performed by the contractor and any subsequent reinspections.
- Review contractor as-builts, including documentation of the size, locations, and orientation of repairs, and facilitate the delivery of the final record drawings to the City.
- Track, compile, and categorize all project related documents, including inspection reports, progress photos, important project correspondence, meeting minutes, RFIs, Submittals, etc., on a flash drive, following completion of the project, and deliver to the City Project Manager.
- Provide data from construction to update Computerized Maintenance Management System per direction of City's Water Asset Management Team.
- Assist with public outreach if required.

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

#### **SECTION III - PRE-SUBMITTAL MEETING**

A pre-submittal meeting will be held at 2:00 p.m. on Monday, December 9, 2024, at 200 W. Washington Street, City Hall Conference Room 9th Floor Training Room. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested consultants attend the pre-submittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

#### SECTION IV - STATEMENT OF QUALIFICATIONS EVALUATION CRITERIA

A Firm will be selected through a qualifications-based selection process based on the criteria below. Subcriteria are listed in order of importance in relation to project services. City of Phoenix project experience is not required.

#### A. Design Experience of the Prime Firm (maximum 150 points)

#### C. Design Experience of the Key Personnel and Subconsultants (maximum 125 points)

- 4. Identify the location of the lead firm's principal office and the home office location of key staff on this project

#### G. Reference Check (maximum 21 points\*)

Use the form provided (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

#### SECTION V - SUBMITTAL REQUIREMENTS

**New Electronic Submittal Process**: Firms interested in this project must submit a Statement of Qualifications (SOQ) electronically through the assigned Contracts Specialist.

Submittal requirements are as follows:

☑ Vendor Information: All firms must be registered in the City's Vendor Management System prior to submitting a proposal. For new firms, the City will send an email to your firm with a vendor number within two business days of submitting the request. The vendor number should be included on the cover of the SOQ. #### ☑ Submittals:

- Submittals must be emailed to the Contracts Specialist by the submittal due date and time.
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name, vendor number, project title, and project number on the cover of the SOQ.
- A maximum of 10 pages is permitted to address all content in the SOQ submittal. (Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.)
- Submit electronically the Statement of Qualifications by 12:00 noon, Phoenix time, on Friday, December 20, 2024.
- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11".
- Font size must not be less than 10 point.
- Content count:
  - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
  - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
  - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.
- ☑ **Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, **legal firm name (not a trade name)**, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. Do not include any additional information.
- ☑ Evaluation Criteria: Address the SOQ evaluation criteria.
- ☑ **Additional Content**: Resumes and other information may be included (*content shall be included within the permitted maximum page limit*).

<sup>\*</sup>These points are in addition to the 1,000 points for the SOQ.

Note: All pages exceeding the specified maximum page limit will be removed from the submittal and not considered in evaluating a submitted SOQ.

#### **SECTION VI – GROUNDS FOR DISQUALIFICATION**

The following will be grounds for disqualification, and will be strictly enforced:

- Violating the "Contact with City Employees" policy contained in this RFQ.
- Submitting to the assigned Contracts Specialist after the submittal due date and time.

#### SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least three, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

The following tentative schedule has been prepared for this project

Pre-submittal meeting December 9, 2024
SOQs due December 20, 2024
Selection Notification Early January 2025
Scope Meeting Late January 2025

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

All submitting firms will be notified of selection outcome for this project. The status of a selection on this project will be posted on the City of Phoenix's "Tabulations, Awards, and Recommendations" website:

The selected Consultant should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement's contract provisions.

#### **SECTION VIII – GENERAL INFORMATION**

**Citywide Capital Improvement Projects.** Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

Changes to Request for Qualifications. Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification. The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

**Alternate Format.** For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

**Release of Project Information/Public Records Request.** The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City. To submit a Public Records Request, visit <a href="mailto:phoenix.gov/prr">phoenix.gov/prr</a>.

**City Rights.** The City of Phoenix reserves the right to reject any or all Statements of Qualifications, to waive any informality or irregularity in any Statement of Qualifications received, and to be the sole judge of the merits of the respective Statements of Qualifications received.

**Contact with City Employees.** This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.** 

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

**Conflict of Interest.** The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

**Protest Procedures.** Firms responding to disqualification or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
