

ADDENDUM 1

CHANGES

1. Section 3.10. - Service Requirement, Paragraph (H) - Landfill Dumping Fees is amended by deleting in its entirety and replacing with the following:

Landfill Dumping Fees: Compactor and open-top emptying charges, less landfill fees, must be stated. The landfill fees will be charged at a per ton rate, per the pricing provided in Exhibit B – Bid Price Schedule. The Contractor must provide a receipt from the landfill, which lists all the landfill dumping fees and tonnage dumped. The receipt will be provided with the Contractor’s invoice.

City waste will not be transported in the same truck as waste from other facilities. Non-City waste is not allowed to be mixed in the same load as City waste.

2. Section 3.13. – Invoicing, Paragraph (B) is amended by deleting in its entirety and replacing with the following:

B. Service will be charged per haul, at the contracted price. In addition, the Contractor will add a line on the invoice for landfill fees. The Contractor will provide the landfill weight ticket listing the weight of the load and the cost for the dump of the waste. Landfill tickets will not be modified in any way.

| 2. | Is the city expecting all rebates for expectable rebates materials etc. (cardboard, metal etc.) | The resulting contract will not be a revenue-sharing contract. The City is not expecting to receive rebates. |
| 3. | What are the service quantities, sizes, and frequencies of the city-owned compactors, and will maintenance be required of the awarded contractor? | <p><u>Service Quantities</u> Co-mingled recyclables average is 4.2 tons per load.</p> <p>Trash average is 6 tons per load.</p> <p><u>Service Frequencies</u> See answer to Question 1.</p> <p>No maintenance will be required of the awarded contractor.</p> |
| 4. | What compactor monitoring systems does PHX currently utilize? | PHX currently utilizes pressure gauges as the monitoring system on compactors. |
| 5. | Can we please receive a service map of the main staging locations and bin quantities? | A service map will not be provided as it is considered Sensitive Security Information. The awarded Contractor will have access to this information. |

| 6. | Per the quantity schedule of commercial bins and open tops, can we receive a breakdown of how many are trash, recycling, or other waste stream? | <p>This solicitation is for trash waste and co-mingled recycling. This solicitation does not include any other waste streams.</p> <p>PHX currently utilizes eight compactors that are designated for co-mingled recycling.</p> <p>PHX currently utilizes 17 trash compactors.</p> <p>PHX currently utilizes two trash open-tops per week.</p> |
| 7. | Where are recycling, metal, and wood disposals being taken currently? Is this mandated as part of the service contract? What accessibility is there for this disposal site, particularly at night and on weekends? | The City currently utilizes internal services to address the recycling of metal, wood, and cardboard. The choice of recycling service provider(s) is determined by the awarded Contractor, and must be in accordance with the stipulations outlined in Section 3.10 – Service Requirement Paragraph (I) – Recyclables. |
| 8. | What is the average tonnage of the stilted compactors, where there is an 11'6" clearance?(aligning equipment needs for service) | <p>The average tonnage of the stilted compactors is:</p> <p>Co-Mingled Recycling average is 4.2 tons per pick up.</p> <p>Trash average is 5 tons per pick up.</p> |
| 9. | In Section 3.1, the RFP states collection of "universal wastes," please describe the nature of these waste materials. | Universal waste is general trash and co-mingled recycling that is collected in trash and recycling bins throughout the airport and surrounding properties. These wastes are common wastes that are collected from passengers, the public, and airport employees. |

| 10. | Are there any available average service frequency, schedule, or tonnage amount for the past year(s) that can be reviewed? | See answer to question number 1. The approximate tonnage for fiscal year 2023 – 2024 was 9,731 tons. Refer to attached 2025 Trash Schedule for further details. |
| 11. | At what frequency does PHX require that the contractor-owned containers be replaced? | Any Contractor owned containers must be replaced if it exhibits holes, noticeable damage, graffiti, or any other potential risks. |
| 12. | Bagged recycling will add an extra cost for service, please confirm this will be approved to pass thru if Contractor is assessed a fee for this. | All co-mingled recycling will be placed in bags. Services for handling and/or debagging co-mingled recycling will not be charged on any invoices. These costs should be incorporated/considered when submitting a bid in response to this solicitation. |
| 13. | What are “typical” service needs on nights, weekends, and holidays? | On-call duties are required during nights and weekends. The regular, established scheduled will continue during holidays, with the exception of Christmas Day, Thanksgiving Day, and New Year's Day. |
| 14. | Are there any extensions available to the February 18 th deadline? | No, an extension will not be permitted at this time. |

| 15. | Does the contractor have the ability to utilize any certified recycle facility or does CoP require the contractor to use specific locations? If so, which locations are approved? | The City does not require the Contractor to use specific locations. The Contractor must accommodate PHX's continued use of plastic bags, and still ensure the recyclable material is recovered, processed, and delivered to secondary markets. |
| 16. | Can you please add additional clarity to the statement below? City waste will not be transported in the same truck as waste from other facilities. Non-City is not allowed to be mixed in the same load as City waste. | Waste collection from the City must not be combined with any other collection sources, as the weight may not be accurately measured if collected from multiple sources, including other City departments and non-City locations. |
