## **REQUEST FOR QUALIFICATIONS**

The City of Phoenix is seeking a qualified consultant team to provide Architectural services for a new Valley Youth Theater Center. Services will include programming, study, site assessment, design, and possible construction administration and observation. This project site is located at the southwest corner of N. 2nd Street and E. Mckinley Street. The estimated construction cost is \$12 million.

This project will utilize General Obligation Bond Program (GO Bond) Funding.

Utilization of Small Business participation is encouraged but is not required.

#### SECTION I - PROJECT DESCRIPTION

On behalf of the Valley Youth Center for the Arts, the City of Phoenix seeks to design a new facility as a permanent home for the Valley Youth Theatre. The facility will include an American Disabilities Act compliant 300-seat feature theatre plus a 99-seat studio theatre for smaller productions. Also included are office and meeting space, restrooms, rehearsal/workshop space, dance studios, galleries and space for set, costumes, prop shops, and storage.

The Phase I Environmental Site Assessment will be available to the selected firm.

#### SECTION II - SCOPE OF WORK

The consultant team will be required to perform a full and complete range of architectural services required for this project. Disciplines may include, but are not limited to civil, traffic, architectural, structural, mechanical, electrical, and fire and safety protection.

It is anticipated the Valley Youth Theatre's fundraising and or public relations efforts will use consultant's prepared graphics, drawings, and/or models of the project.

The consultant team will be responsible for general project administration, schematic design/pre-design phase (30%), design development phase (60%, 90% and 100%), cost analysis, construction documents and specifications, and possible construction administration, materials testing coordination, and observation services.

It is anticipated that this project will be implemented through a Construction Manager at Risk (CMAR) contract.

The consultant shall have demonstrated experience in design and construction administration and observation on similar projects.

General Project Administration shall include, but not be limited to:

- Coordinate with the City and CMAR during the design of the project
- Attend all project meetings as necessary to maintain the project objectives
- Submit and retrieve all required documents to and from various agencies
- Coordinate all permits and approvals from federal, state, county, and local utility authorities
- Prepare and submit written monthly progress reporting during entire design period

Pre-Design services shall include, but not limited to:

- Lead meetings with stakeholders to validate space program requirements
- Develop preliminary plans and renderings to present concepts and verify course of the project
- Prepare and reconcile cost models and preliminary timelines for the project

Design services shall include, but not to be limited to:

- Develop project program to meet requirements of the City of Phoenix and the Valley Youth Theatre
- Prepare necessary exhibits and make presentations to stakeholders
- Participate in City coordinated public information, public relation services and community outreach
- Develop studies to lead to recommended solutions during the decision-making process
- Consult with the City to meet project requirements
- Design project to conform to requirements of Title 34, Arizona Revised Statutes
- Address stakeholder and CMAR design / constructability review comments from milestone reviews
- Prepare construction cost estimates for each design phase milestone
- Review recommendations regarding cost models/GMPs provided by the CMAR contractor
- Perform value engineering / cost reduction efforts to optimize project budget
- Develop a schedule for City approval of design submittals for Planning Department review(s)
- Identify private and public utility easements
- Conduct geotechnical engineering and investigations of project site
- Investigate and design utilities and infrastructure for project development (including but not limited to water, sewer, and stormwater
- Coordinate with CMAR in developing design documents
- Coordinate and submit the design packages to CMAR for bid to subcontractors
- Design and prepare project plans and specifications for construction
- Work with City and stakeholders for space planning and layout requirements
- Work with stakeholders from various agencies as required
- Sustainable design
- Other services as required to support successful completion of the work and the City's and Valley Youth Theatre interests

Possible Construction Administration and Observation (CA&O) services shall include, but not be limited to:

- Provide general project administration and construction observation to ensure compliance with the project plans and specifications
- Provide resident engineering services during construction and act as the City's representative
- Hold on-site and off-site meetings as appropriate with CMAR, City staff, impacted third parties, utilities, and agencies as required
- Participate in the CMAR construction progress meetings and other project meetings
- Perform record keeping and maintain project documents including correspondence, schedules, submittals, test data, payments, meeting minutes, specifications, drawings, photographs, shop drawing, as-builds, etc.
- Review and comment on CMAR construction submittals; product data, shop drawings, samples, etc.
- Perform field observations and prepare reports to ensure compliance with the project plans and specifications and to keep City informed of project status and issues
- Participate in cost/credit change review meetings with third party estimators
- Review and certify CMAR monthly progress payments
- Notify CMAR and Owner of any unsafe conditions observed at the construction site(s)
- Schedule, conduct and provide documentation for regular progress meetings with client
- Respond to Request for Information (RFI) and Change Order requests (issue interpretations and clarifications of the construction documents)
- Verify compliance with contract documents
- Conduct pre-final and final walkthrough
- Conduct Substantial Completion walkthrough

- Issue recommendation for Substantial Completion
- Review and comment on closeout documentation, which includes CMAR's as-built documents to incorporate into project record documents
- Review CMAR's record drawings monthly and prepare final record drawings
- Prepare and submit punch list and record documents
- Observe building system equipment start-up and commissioning
- Conduct 11-1/2 month warranty walkthrough and inspection
- Other services as required to support successful completion of the work and the City's interests

Use of UNIFIER, an Application Service Provider (ASP) web-based project management database, may be required. The following information provides a guideline for utilization. Any questions related to the requirements of UNIFIER should be directed to the Project Manager.

- The Consultant will be required to maintain all project records in electronic format.
- The City provides an ASP web-based project management database which the Consultant will be required to utilize in the fulfillment of the contract requirements.
- The Consultant shall provide a computerized networked office platform with broadband internet connectivity.
- UNIFIER training will be provided through the City of Phoenix to firms under contract.

It is strongly recommended that interested firms attend the pre-submittal meeting. - 3. Organization chart showing key personnel, current professional licenses or certifications, and assigned roles for both Design and Construction Administration and Observation Services for the project.
- 4. Identify the following key personnel: Lead Project Manager, Cost Estimator, Civil/Site, Structural and MPE Engineers of Record, Architect of Record (if different from Lead), Project Designer (if different from lead), and Project Architect (if different from lead). Note: All positions must be licensed in the State of Arizona. The Firm may also include resume data for other personnel/subconsultants that you consider key.
- 5. Identify the location of the lead firm's principal office and the home office location of key staff on this project

#### G. Reference Check (maximum 21 points\*)

Use the form provided (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

\*These points are in addition to the 400 points for the SOQ.

- Submittals must be emailed to the assigned Contracts Specialist by the submittal due date and time.
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm legal registered name, vendor number, project title, and project number on the cover of the SOQ.
- A maximum of **15 pages** is permitted to address all content in the SOQ submittal (*Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.*)
- Submit the Statement of Qualifications by 12:00 noon, local time, on Friday, February 28, 2025.
- Page size must still meet requirements of 8<sup>1</sup>/<sub>2</sub>" x 11"
- Font size must not be less than 10 point
- Content count:
  - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
  - Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
  - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages will NOT be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.
- ☑ **Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, legal firm name, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. Do not include any additional information.

#### SECTION VI - GROUNDS FOR DISQUALIFICATION

The following **will be grounds for disqualification**, and will be strictly enforced:

- Submitting a Statement of Qualifications to the assigned Contracts Specialist after the due date and time.
- Submitting a Statement of Qualifications to the assigned Contracts Specialist for a different project.
- Violating the "Contact with City Employees" policy contained in this RFQ.

#### SECTION VII - SELECTION PROCESS AND SCHEDULE

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

Finalists from the SOQ evaluation will be invited to participate in detailed interviews. A letter to each finalist will contain the evaluation criteria to be used during the interview presentation. Interview evaluations to select the highest qualified firm include scores from the SOQ evaluation process. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least three, but not more than five firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

**Changes to Request for Qualifications.** *Any changes to this Request for Qualifications (RFQ) will be in the form of a Notification.* The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the Statement of Qualifications, if a Notification has been issued. Registered

RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

**Conflict of Interest.** The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

**Protest Procedures.** Firms responding to disqualification or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
