- SBE goal for construction phase will be established upon substantial completion of design






SMALL BUSINESS ENTERPRISE PROGRAM (SBE)

PROJECT DESCRIPTION [ENG & CMAR]

- → This project is necessary because the current system is 20 years old, obsolete, past its useful life and sunset in 2018
- Replacement and repair parts are no longer available
- Project replaces most control panels, initiating and indicating devices
- RCC control panels will be reduced from 23 to 5 or 6
- > RCC business suites are out of sync




PROJECT DESCRIPTION [ENG & CMAR]

- Much of EEP work will be replacing devices with updated ones
- Some existing conduit and wire can be reused, but much will need modification and/or replacement to reduce complexity
- Underground wire and possibly some conduit will need replacement
- → Project will install emergency communications system
- → Modify system operation so building levels, not cores, are synced at RCC, including garage and CSB

PROJECT EXPECTATIONS [ENG & CMAR]

- → Familiar with fire alarm design/construction in airport landside environment
- Comply with current City, county, state, federal, NFPA and any other applicable codes
- → Integrate into existing systems with minimal disruption requiring 24/7 fire watch
- Be compatible with current fire alarm network infrastructure and monitoring systems
- Need system that is easier to maintain and test and is consistent with systems in other buildings



PROJECT EXPECTATIONS [ENG & CMAR]

- Minimal impact to airport operations will involve night construction
- Up to date with current fire alarm technology
- Coordinate with stakeholders, including the following:
 - City Aviation Facilities and Services personnel, particularly Energy Division
 - Fire and Police Departments
 - Landside Operations
 - Rental Car companies and other Tenants

Maximum Number of Points is 1,000

- A. Design Experience of the Prime Firm (150 points)
- B. CA&I of the Prime Firm (150 points)
- C. Design Experience of Key Personnel and Subconsultants (125 points)
- D. CA&I Experience of Key Personnel and Subconsultants (125 points)
- E. Project Understanding and Approach (300 points)
- F. Staffing Information for Key Personnel (150 points)

*Reference Checks (21 Points)

These points are in addition to the 1,000 points for the SOQ



SOQ EVALUATION CRITERIA [CMAR]

Maximum Number of Points is 1,000

- A. General Information (150 points)
- B. Experience and Qualifications of the Firm (250 points)
- C. Experience of Key Personnel to be Assigned to this Project (250 points)
- D. Understanding of the Project and Approach to Performing the Required Services (350 points)

*Reference Checks (21 Points)

These points are in addition to the 1,000 points for the **SOQ**



SUBMITTAL REQUIREMENTS [ALL]

Submit One (1) page Information Sheet

Paper Size $8\frac{1}{2}$ " x 11"; Font size no less than 10 pt.

Each page containing resumes, evaluation criteria, and additional content will be counted toward the maximum page limit

Pages that have project photos, charts and/or graphs will be counted toward the maximum page limit noted above



MAXIMUM PAGE COUNT [ALL]

12 pages permitted to address all Criteria

The following will <u>NOT</u> be counted in the Maximum Page Count:

- * Front and back covers
- * Information Sheet
- * Table of Contents
- * Dividers (tabs)

UNLESS you include information that may be considered by the selection panel
