## FIRE STATION 15

### **PROJECT OVERVIEW**



## PROJECT DESCRIPTION

- Phoenix Fire Station No. 15 is a new single-story building of approximately 20,810 square feet. The proposed facility includes four apparatus bays, 16 dormitories, fitness room, community room, kitchen, and work/living spaces. The fire station is designed per the City of Phoenix Fire Department building design standards and will incorporate environmental design principals like LEED to reduce energy consumption and water preservation. The building envelop is composed of insulating concrete forms and concrete masonry unit walls with conventional wood, steel framing, and insulated metal deck roof.
- The developed site is approximately 7.07 acres of undeveloped desert rangeland located on the southwest corner of 45th Avenue and Camelback Road. Sewer and Water services will be extended from the right-of-way.



## JOB SITE ACCESS / SECURITY



Site Access: preferred from 45<sup>th</sup>, stay away from residential areas

## Contractor is responsible for securing the site using best practices

Contractor use of site is limited as indicated. Use of site outside indicated limits for stagging and parking, if needed, must be approved by the City.



- Permits: The City will pay for all City of Phoenix required permits
- Project Schedule: 395 days from NTP
- Successful bidder will work with the City to pre-order long lead items, such as SES equipment


- Work hours 7 am to 5 pm, unless otherwise approved by special permit
- Protect existing site and street improvements indicated to remain and adjacent to new construction from damage
- READ contract requirements and specifications

## SCHEDULE OF ALLOWANCES

- Allowance 1: Unforeseen Circumstances for a lump sum of \$150,000.00
- Allowance 2: FFE & Owner for the lump sum of \$750,000.00





- Allowances shall cover the cost to the Contractor for the materials, equipment and installation required by the allowance delivered to the site, and all applicable taxes
- The Contractor's costs for receiving and handling on the site, overhead, profit, and other expenses contemplated for the original Allowance shall be included in the Contract Sum and not in the Allowance
