# REQUEST FOR QUALIFICATIONS

The City of Phoenix is seeking a qualified consultant team to provide construction administration and inspection services for the Booster Pump Station (BPS) 10A-B1 and Cave Creek Lone Mountain Waterline project which will construct a new 5.8 million gallons per day BPS and approximately two miles of new 16" waterline to connect between existing infrastructures. The estimated total construction cost for this project is \$16.5 million.

## **SECTION I – PROJECT DESCRIPTION**

The City needs to construct a new 5.8 million gallons daily (MGD) BPS at the City's existing Well 300/9A-B2/9A-GS2/10A-B1 site, approximately 0.9 mile of new 16-inch waterline between existing infrastructure south of Carefree Highway and the new BPS, approximately 1.1 mile of new 16-inch waterline along Lone Mountain Road, and approximately 0.2 mile of 20-inch waterline along Cave Creek Road to supply the new BPS. The waterline improvements are required for system resiliency when the new BPS is in operation.

The proposed BPS and waterlines will require extensive coordination with Operations, Distribution, and other divisions, as well as with the Town of Cave Creek and their representatives. As both waterlines must be operational for the BPS improvements to come online, construction activities will need to be performed in parallel within a tight construction schedule and budget. It is anticipated the construction will be completed by Winter 2023. The selected firm will also need to coordinate with Remote Facilities and Distribution for shutdown and isolation of the BPS and Waterlines.

The design and construction for this project includes the following, but are not limited to:

### **BPS 10A-B1 (33005 N 52<sup>nd</sup> St)**

- Firm Capacity: 5.8 MGD
- New mechanical equipment, including all new pumps, pump cans, suction and discharge piping, valves, and related equipment,
- New surge/hydropneumatic system,
- Upgraded primary electrical service,
- New Service Entrance Section,
- New electrical gear, instrumentation, and controls,
- New generator to meet increased standby power requirements,
- Site improvements, including rehabilitation and improvements to the existing 9A-B2 BPS that served the existing 10A-B1 BPS that will be demolished, and
- Demolition of the existing 10A-B1 BPS, associated electrical gear, instrumentation, and controls

### **16" Waterline in Cave Creek Road (between Apache Rain Road to Carefree Highway)**

- Approximately 4,800 Linear Feet (LF) of 16" Ductile Iron Pipe (DIP) in Cave Creek Rd.
- Approximately 1,200 LF of 20" DIP for 10A-B1 suction piping
- Extension of an existing 12" DIP waterline near the intersection of Cave Creek Road and Carefree Highway to tie into the 16" waterline
- Extension of an existing 8" DIP waterline to tie into the new 16" main
- Relocation of existing service and fire service connections to the new watermain
- Miscellaneous other minor service connection tie-ins, and
- Cathodic protection as required.

### **16" Waterline in Lone Mountain Road (between Cave Creek Road and 56th Street)**

- Approximately 6,300 LF of 16" DIP in Lone Mountain Rd.,
- New fire hydrants being added to existing distribution main in Lone Mountain Rd.,
- Connections to existing mains at Cave Creek Rd. and 56th St., and
- Cathodic protection as required.

## **SECTION II – SCOPE OF WORK**

The services provided by the consultant may include, but are not limited to, the following:

- General construction administration and oversight
- Confirm contractors' work progress and qualities of work completed.
- Construction inspection and materials testing services, including preparation of punch lists for corrective work to be performed by the contractor and any subsequent re-inspections.
- Startup and commissioning services, including Agency coordination and permitting
- Review contractor as-builts, including documentation of the size, locations, and orientation of repairs, and facilitate the delivery of the final record drawings to the City.
- Track, compile, and categorize all project related documents, including inspection reports, progress photos, important project correspondence, meeting minutes, Request for Information, Submittals, etc., on a flash drive, following completion of the project, and deliver to the City Project Manager.
- Provide data from construction to update Computerized Maintenance Management System per direction of the City's Water Asset Management Team.
- Assisting the City with public outreach coordination

The selected firm will provide an individual to manage and lead their team and will commit this individual to the project for its duration. This individual will serve as the City's representative during construction of this project and will work with and under the direction of the Water Services Department's construction project manager.

### **SECTION III - PRE-SUBMITTAL MEETING**

A pre-submittal meeting will be held at 11:00 a.m. on Monday, October 4, 2021, via WebEx. At this meeting, City staff will discuss the scope of work, general project requirements, and respond to questions from the attendees. It is strongly recommended that interested consultants attend the pre-submittal meeting. Inquiries regarding the project scope outside of this pre-submittal meeting must be directed to the Contracts Specialist.

### **SECTION IV - STATEMENT OF QUALIFICATIONS EVALUATION CRITERIA**

A Firm will be selected through a qualifications-based selection process based on the criteria below. Sub-criteria are listed in order of importance in relation to project services. City of Phoenix project experience is not required.

#### **A. Construction Administration and Inspection Experience of the Prime Firm (maximum 250 points)**

Describe the experience and qualifications of the prime firm in providing CA&I services for similar projects. Identify projects the submitting firm has completed. For each project listed, provide:

1. Description of the project including scope and project owner.
2. Role of the firm and explain how this relates to the services being solicited.
3. Project's original contract value, final contract value, and reason for variance.

4. Project's start date and completion date.

**B. Construction Administration and Inspection Experience of Key Personnel and Subconsultants (maximum 200 points)**

Describe the experience and qualifications of the project team expected to be assigned to this project in providing CA&I services for similar projects. For each key person identified, list their length of time with the firm. List each key person's role in the projects provided. If a project selected for a key person is the same as one selected for the firm, provide just the project name and the role of the key person. For each project listed, provide:

1. Description of the project including scope and project owner.
2. Role of the firm and explain how this relates to the services being solicited.

4. Identify the location of the lead firm's principal office and the home office location of key staff on this project.

**E. Reference Check (maximum 7 points\* each)**

**Use the form provided** (Exhibit A) to obtain at least three references. It is preferred no more than one be a City of Phoenix project. If your firm has not completed prior projects with other agencies, you will not be penalized. It is recommended there be references outside the City of Phoenix.

\*These points are in addition to the 1,000 points for the Statement of Qualification (SOQ).

**SECTION V - SUBMITTAL REQUIREMENTS**

**Electronic Submittal Process:** Firms interested in this project must submit a SOQ electronically through the ProcurePHX online portal.

Submittal requirements are as follows:

- Vendor Information: All firms must be registered in the City's Vendor Management System prior to submitting a proposal. For new firms, the City will send an email to your firm with a vendor number within two business days of submitting the request. The vendor number should be included on the cover of the SOQ. **Submittals:**

- Submittals must be uploaded to the ProcurePhx website by the submittal due date and time.
- Submit only one SOQ electronically, in .PDF format only, addressing all evaluation criteria. No hard copies will be accepted.
- Clearly display the firm name, vendor number, project title, and project number on the cover of the SOQ.
- A maximum of **10 pages** is permitted to address all content in the SOQ submittal (**Maximum page limit includes evaluation criteria and all additional content. It does not include information sheet.**)
- Submit electronically the SOQ by **12:00 noon, Phoenix time, on Friday, October 15, 2021.**
- Upload one complete version of the SOQ addressing all the criteria. Upload format is .PDF.
- Page size must meet requirements of 8½" x 11"
- Font size must not be less than 10 point
- Content count:
  - ✓ Each side of a page containing evaluation criteria and additional content will be counted toward the maximum page limit noted above.
  - ✓ Pages that have project photos, charts and/or graphs will be counted towards the maximum page limit noted above.
  - ✓ Front and back covers, information sheet, Table of Contents pages, and divider (tab) pages **will NOT** be counted toward the maximum page limit noted above, unless they include evaluation criteria and additional content that could be considered by the selection panel.

**Information Sheet:** Provide an information sheet that includes project title, project number, RFx number, firm name, address, phone number, vendor number, and the name, title, email address and signature of your contact person for the project. Do not include any additional information.

**Evaluation Criteria:** Address the SOQ evaluation criteria.

**Additional Content:** Resumes and other information may be included (*content shall be included within the permitted maximum page limit*).

**Note: All pages exceeding the specified maximum page limit will be removed from the submittal and not considered in evaluating a submitted SOQ.**

## **SECTION VI – GROUNDS FOR DISQUALIFICATION**

The following **will be grounds for disqualification**, and will be strictly enforced:

- Failure to submit electronically through the ProcurePHX online portal by the due date and time.
- Violating the “Contact with City Employees” policy contained in this Request for Qualification (RFQ).

## **SECTION VII - SELECTION PROCESS AND SCHEDULE**

Interested firms will submit a SOQ. The firm will be selected through a qualifications-based selection process. A selection panel will evaluate each SOQ per the criteria set forth in Section IV above.

The City will select a firm based on the SOQs received; no formal interviews will be conducted. The City may conduct a due diligence review on the firm receiving the highest evaluation.

The City expects to create a final list of at least one, but not more than three firms for this project. The City will enter into negotiations with the selected firm and execute a contract upon completion of negotiation of fees, contract terms, and City Council approval.

The following tentative schedule has been prepared for this project.

Pre-submittal meeting	October 4, 2021
SOQs due	October 15, 2021
Scope Meeting	November 2021

If the City is unsuccessful in negotiating a contract with the best-qualified firm, the City may then negotiate with the next most qualified firm until a contract is executed, or the City may decide to terminate the selection process. Once a contract is executed with the successful firm, the procurement is complete.

All submitting firms will be notified of selection outcome for this project. The status of a selection on this project will be posted on the City of Phoenix's "Tabulations, Awards, and Recommendations" website:

The selected Consultant should expect to comply with the Arizona State Statutes Title 34 and City of Phoenix Design and Construction Procurement's contract provisions.

## **SECTION IX – GENERAL INFORMATION**

**Citywide Capital Improvement Projects.** Consulting and contractor services supporting the City's Capital Improvement Projects are procured under the authority of the City Engineer, currently located within the Street Transportation Department. Design and Construction Procurement coordinates the citywide consulting and construction contracting procurement processes.

**Changes to Request for Qualifications. *Any changes to this RFQ will be in the form of a Notification.*** The City of Phoenix shall not be held responsible for any oral instructions. Notifications are available on both the Current Opportunities and ProcurePHX webpage.

***It shall be the responsibility of the registered RFQ holder to determine, prior to the submittal of the SOQ, if a Notification has been issued.*** Registered RFQ holders may refer to the web page or call the Contracts Specialist (listed below) to ascertain if a Notification has been issued for this project.

**Alternate Format.** For more information or a copy of this publication in an alternate format, contact the Contracts Specialist (listed below) - Voice or TTY 711. Requests will only be honored if made within the first week of the advertising period.

**Release of Project Information.** The City shall provide the release of all public information concerning the project, including selection announcements and contract awards. Those desiring to release information to the public must receive prior written approval from the City.

**City Rights.** The City of Phoenix reserves the right to reject any or all SOQ, to waive any informality or irregularity in any SOQs received, and to be the sole judge of the merits of the respective SOQs received.

**Contact with City Employees.** This policy is intended to create a level playing field for all Proposers, assure that contracts are awarded in public, and protect the integrity of the selection process. **OFFERORS THAT VIOLATE THIS POLICY WILL BE DISQUALIFIED.**

Beginning on the date the RFQ is issued and until the date the contract is awarded or the RFQ withdrawn, all persons or entities that respond to the RFQ, including their authorized employees, agents, representatives, proposed partner(s), subcontractor(s), joint venture(s), member(s), or any of their lobbyists or attorneys (collectively the Proposer), will refrain from any direct or indirect contact with any person (other than the designated Contract Specialist) who may play a part in the selection process, including members of the evaluation panel, the City Manager, Assistant City Manager, Deputy City Managers, Department heads, the Mayor and other members of the Phoenix City Council. As long as the RFQ solicitation is not discussed, Proposers may continue to conduct business with the City and discuss business that is unrelated to this RFQ solicitation with City staff.

Commencing on the date and time a solicitation is published, potential or actual proposers (including their representatives) will only discuss matters associated with the solicitation with the Mayor, any members of City Council, the City Manager, any Deputy City Manager, or any department director directly associated with the solicitation (including in each case their assigned staff, except for the designated procurement officer) at a public meeting, posted under the Arizona Revised Statutes, until the resulting contract(s) are

awarded or all offers or responses are rejected and the solicitation is cancelled without any announcement by the procurement officer of the City's intent to reissue the same or a similar solicitation.

Proposers may discuss their proposal or the RFQ solicitation with the Mayor or one or more members of the Phoenix City Council, provided such meetings are scheduled through the Contract Specialist (listed below), conducted in person at 200 W. Washington, Phoenix, Arizona 85003, and are posted as open meetings with the City Clerk at least twenty-four (24) hours prior to the scheduled meetings. The City Clerk will be responsible for posting the meetings. The posted notice shall identify the participants and the subject matter, as well as invite the public to participate.

**Conflict of Interest.** The City reserves the right to disqualify any Proposer on the basis of any real or apparent conflict of interest that is disclosed by the proposal submitted or any other data available to the City. This disqualification is at the sole discretion of the City. Any Proposer submitting a proposal herein waves any right to object now or at any future time, before any body or agency, including but not limited to, the City Council of the City of Phoenix or any court.

**Protest Procedures.** Firms responding to disqualification or a procurement outcome are referred to the Code of the City of Phoenix Chapter 2, Article XII, Section 2-187 to 2-190.4, which governs protest procedures utilized throughout the selection process.
