 - Section V, Scope, Item 1. Purpose, has been revised to read as follows:

The City of Phoenix (City) is seeking a Contractor to supply twin-engine helicopter in accordance with the specifications herein. In addition, the Contractor will manage, oversee completion of mission configuration installation, and provide manufacture training. The City's initial acquisition will be one factory new helicopter with the option of purchasing a second during the course of the contract.

- Section V, Scope, Item 9, Warranties, has been revised to read as follows:
 - 9.1. In addition to Section III, Item 21, Warranties shall have "commencement dates" in conjunction with delivery of customization work of aircraft and when the aircraft is placed into service with the City, not the date of manufacture
