| 3. Is the funding for only one year, or is it for multiple years? The RFP states " The City anticipates a one-year term beginning on or about July 1, 2022, to December 31, 2024". This timeframe is over a 2 1/2-year period. And later in the RFP (Appendix B on page 48) you supply a performance outcome template asking for outcome measures for Year 1, Year 2, and Year 3. I am confused on the funding timeframe, one year or multiple years.? | The contract term will be from approximately July 1, 2022, through December 31, 2024, not one-year with renewals. |
| 4. Is MCCCDC being paid tuition for individuals served by this funding? The RFP states "Separate funding is set-aside for Maricopa Community College classes and related expenses." I don't know if this means that tuition will be paid directly to the colleges, or if this funding covers tuition. I ask because our program has provided supplemental support of tuition for students in the past and need to know if this should be considered for budgeting purposes. | Yes, MCCCDC will be paid directly for the costs of training by the City of Phoenix with funds set-aside and managed by City of Phoenix staff. |
